- b) served at least 15 years as a District Administrator during which time has been directly involved with the administration of SV
- c) has competed successfully at international level as a member of an Australian team or teams for at least 6 years
- d) worked actively as a qualified Technical Official for a period of at least 25 years;
- e) other direct service to SV for at least 10 years
